QUESTIONS/COMMENTS RECEIVED

Question 1. Is it possible to push the proposal deadline back two days to Wednesday? With a deadline on Monday at 10am, we cannot comfortably assume that FedEx will have the proposal there over the weekend.

Proposals will be accepted and may be submitted prior to the 10:00am September 26th deadline. Staff will begin reviewing proposals promptly on Monday, September 26th after the 10:00am deadline in preparation for updates to the Airport Authority Board Committees on Tuesday, September 27th and potential interviews with proposers in the weeks to follow.

Question 2. Is all the equipment listed on "Landside Restaurant Authority Owned Equipment List" in workable order?

As far as the Authority has been made aware, there currently is no equipment that is not in workable order.

Question 3. If there is any equipment that is not operational, will the Authority pay to have such equipment repaired or replaced?

If there is Authority Owned Equipment that is not operational, the Authority will replace such equipment as appropriate.

Question 4. The Hours of Operation are different in the Sample Concession Agreement than the Request for Proposal. Can we have flexibility for hours of operation, especially for the landside restaurant and coffee shop?

The Sample Concession Agreement with the RFP was included only as a sample. To provide a quality service to visitors of Bishop International Airport, the hours of operations identified in the RFP are those desired for visitors to obtain food service. If it is anticipated that different hours of operation or flexible hours would be more beneficial at particular locations, please include this information with the submitted proposal.

Question 5. The Monthly base fee is only 8% and reconciled at year-end in the Sample Concession Agreement. Is this correct?

The Sample Concession Agreement with the RFP was included only as a sample. Page 3 of the Sample Concession Agreement references 10% of gross revenues. Additionally, the Key Business Terms on Page 7 of the RFP should be referenced for minimum percentage rent rate. Typically, there is no year-end reconciliation needed as concessionaires usually pay only a percentage of revenue received without a required Minimum Annual Guarantee.

Question 6. The Term in the Sample Concession Agreement states that it starts 11/1/2022 and ends 11/30/2032. For the post-security areas, this is only a nine-year term. Currently, based on start date of 12/1/2023 and expiration date of 11/1/2023 for the airside area, the RFP is actually a 9-year contract. Can this be extended to a full 10-year contract?

It would be acceptable for the 10-year term to begin on 12/1/2023. This potentially would result in a longer than 10-year term for other locations within the Terminal Concessions Agreement that would take effect this year.

Question 7. Can we see a revenue history for the current and past concessions covered in this RFP?

See below for a historical review of revenue. Landside includes strictly the landside space and was closed in March 2020. The Airside includes both the bar and grill.
