The awarded roofing contractor shall install Firestone Building Products or Carlisle SynTec Systems labeled roofing materials only. No other manufacturers will be considered at this time. If the Prime Bidder is not prequalified with Firestone Building Products or Carlisle SynTec Systems, then the Prime Bidder must use a prequalified subcontractor which is prequalified. This subcontractor(s) must be designated prior to award of the contract.
