Position Summary

The Director of Information Technology will manage the Authority's network, information technology (IT) and operational technology (OT) operations across all departments (administration, public safety, maintenance & facilities, and operations) in conjunction with staff and external IT and other service providers.

Duties and Responsibilities

- Design and implement short- and long-term strategic plans to ensure systems meet existing and future requirements
- Develop, implement, and maintain policies and procedures for systems administration and project management
- Prepare RFPs, bid proposals, contracts, scope of work reports, and other documentation for IT infrastructure projects and procurement of third party vendors and contractors for managed services IT, OT, and telecommunication services
- Manage support agreements and maintain relationships with external IT vendors and service providers
- Set and manage priorities for the design, maintenance, development, and evaluation of all systems including local and cloud-based solutions
- Identify, track, and manage upgrades to network assets and infrastructure; this includes associated switches, routers, firewalls, modems, fiber optic cables, wireless access points, network cables and telephone infrastructure
- Prepares and monitors annual budget for IT infrastructure and related services
- Practice asset management including maintenance of component and software inventory
- Develop and maintain business continuity and disaster recovery plans
- Plan, implement, upgrade, and monitor security measures for the protection of computer networks and information
- Respond to computer and network security breaches, cybersecurity attacks, and viruses, and work with third-party contractors to remediate
- Provide support to users and educate on best practices
